Grants and future events

Report from Sheila – read out by Dave. The Tesco grant report was submitted and has been accepted. We are able to apply for another grant if we wish, although not for the same project. I was concerned to hear from Cliff that the wood we bought for £900 (£500 from WCC Environment Fund and £400 from Tesco, roughly speaking) has not yet been used. I would not want to apply for any more grants from these two bodies until we have used the wood.

We were successful in getting the grant from WCC for the coach for the trip to Southend on 4th August and advertising for this is now going ahead. Thanks to all for acknowledging WCC in the publicity. Please remember we need someone on standby to help if there is a problem with losing someone on the day. I did this last year but I cannot on 4th August.

I wrote to Mavis and John to ask if we have received our "Healthcheck" grant from MKC grant from MKC. If we have not I will write to Michael Kelleher asking who I should talk to about it.

More importantly, we should now be applying for grant aid from MKC for a summer event. Last year we got £400 and it seems from what Michael has said that it will be the same again this year. What are we going to do? What costs should I put in the application to justify the award of £400?

We brainstormed on possible ideas for a summer event, including another dog show. All agreed we need volunteers to arrange and implement any ideas. There has been no response to repeated requests for input to a summer culture day so it was agreed we would not continue with this proposal.

John said a woman (Sinead?) had offered to run evening dram classes. All agreed this would be supported by us in terms of materials/hall hire. Action: Lesley and John both offered to discuss further with Sinead.

Ron suggested the Rubbish collection advice should be repeated again in June issue. This led to a long discussion on rubbish collection.

Regeneration Watch

Progress has been made on forming a collective action group as a follow up from last year's first meeting of the Regen estates. First meeting was held 8 June and attended by representatives from the seven estates. From this:

- A letter to the MKC signed by the seven RA Chairs was emailed 11 June to MKC
- Agreement to form a formal Association of Regen RAs. MK Action will facilitate on 22 June.

It was noted that all Fullers Slade RA officers resigned on 11 June as a protest because YourMK do not listen to it.

Also – there is an important MKC Cabinet meeting on 10 July to receive/consider a policy document on Regeneration.
