1) Matters arising not elsewhere on the agenda

- Terry and Derek have completed the Housing Allocation consultation with Dave L 's help.
- Storage bins Rosemary have looked at costs metal bins are £18.00 each.
- The Agreement with WCC still to be followed up between Sheila and John.
- Welcome Pack Derek has provided photos to Rosemary, who has asked for more and he agreed to do this and get them to Rosemary. Sian has the pack and the meeting agreed to pay the £60 required for binders from the £188.03 left over from the WCC grants. (Sheila has permission from MKC to do this).

4) Grants update

- Sheila will apply for the summer seaside trip when a destination has been decided. The meeting suggested 10 August. Dave L. had done a preliminary survey on the TBRA Facebook page. Votes have been

We asked about Barrie White's Regen plan – it was approved by Savlles and we understand that some ideas from it are include in some proposed concepts FS have established a fruit barrow on the estate, for distributing free fruit and vegetables.

8) AOB

Dave Lee will begin to complete the Health Check paperwork.

Regen: Kathy suggested we should establish a TBRA Regeneration subcommittee. The idea is that this will pre-empt any MKC imposed Steering Group at the time they come to the estate to begin Regen work. An established subcommittee of the TBRA will be difficult to ignore.

Through this we can begin to carry out a survey to ask council tenants for their own priorities in regard to Regen spending.

We need to recruit Council tenants to this sub-committee. Various names where suggested.

Kathy suggested that some of us could offer secretariat services to this subcommittee.

The TPAS conference is on July 10/11. Terry and Derek are interested to attend. Kathy said he will find out if there is any financial support for attendance.
